

Collect Required Documents and Register Online or In Person

Register online or in person with your required documents (see back page for list of required documents). If you would like help, please request an appointment by emailing enrollment@k12.somerville.ma.us or call 617-629-5670. Our staff speak English, Spanish, Portuguese, and Haitian Creole. We also have a language line to provide support in any language.

Documents Reviewed

Your documents are reviewed by the Enrollment Office including a recent completed physical examination with immunization records (an updated one within one year of school entry will be required). https://somerville.kt2.maus/districtdepartments/enrollment-office/ required-health-documentation

English Language Assessment

If your child speaks or understands a language in addition to English, we must collect information about their English Language Learner history from their previous school. If this is the first time your child will be attending school in the United States, we will schedule a language assessment to determine the best program for them.

School Assignment

Once your child has been medically cleared and all documents have been received, you will be assigned a school based on Somerville School Committee policy which prioritizes program need, sibling preference, and proximity (school to which your address is connected).

What documents do I need for school registration?

1. Your valid photo ID

 Massachusetts ID, driver's license, passport, or other government-issued photo identification (of the parent/guardian registering the child, not the child's)

2. Your child's birth certificate (not hospital letter)

3. One (1) proof of residency:

- Copy of signed current lease –including SHA and HUD leases (1st page with name and address and last page with signatures)
- Copy of most recent mortgage statement (or if home no longer has a mortgage, a copy of the deed)
- Notarized residency affidavit (available on the website https://somerville.k12.ma.us/residency or provided by the Enrollment Office] and filled out by the landlord or person with the lease AND one of the following: a copy of a utility bill in the landlord or lessee's name, rent receipt, or cancelled check (front and back) from rent payment
- Section 8 agreement

4. One (1) proof of occupancy:

- A utility bill or work order dated within the past 60 days, including: gas bill, electric bill, oil bill, cable bill, cell or home phone bill
- Property tax bill
- Current vehicle registration or excise tax bill dated within the past year
- Letter from Mass Health or private health insurance agency
- Printed pay stub
- W-2 form (dated within the past year)

5. Your child's most recent immunization & health records

- A recent completed physical examination with immunization records (an updated one within one year of school entry will be required)
- Doctor's orders if your child will need to take medication during the school day

6. Prior school records (Grades 1–12 ONLY):

- · Your child's most recent official school transcript, and
- In the case of High School registration or transfer:
- Discipline report from all high schools the child attended

7. Other important documents as needed

- Active IEP, 504 plan, custody agreements, guardianship, court order, etc.
- Current Access Scores (for English Language Learners)

- to support families and be "warm demanders" for our bureaucratic function of collecting required paperwork
- to provide schools/staff the information they need about new students and family



On a macro level we aim to assist in the development of trust between residents and civic institutions (schools/city)

We refer families to supports available through the SFLC such as Somerbaby, Parent Child+, Office of Basic Needs and Housing Support Services, and other departments like SomerPromise, Project Soup, OHS, Community Schools, SCALE, Office of Immigrant Affairs, Recreation and the Public Libraries.




Much of our work with families is done individually on a case by case basis.

Since January 2023 we have supported 345 families for SY23-24 enrollment with in-person registration, about 26% of all registrations.

Frequently asked questions from families

Do I have to live in Somerville to attend Somerville Public Schools? What is the best school to select for my first choice? Is there school bus transportation for students? Why is there no sibling preference for the PK lottery? What do we do if we don't have a lease and are just renting a room? How can we register for health insurance if we are new to the country? How does the waitlist work? How do I apply for apply for after school care? We work between two primary computer systems:

 PowerSchool - what families use to apply and the system that conducts our PK/K lottery
ASPEN - District SIS (Student Information System) which support state reporting SPS Enrollment as of October 1



Changes for SY 24-25

- Sonrisa program moved from Healey to East. This location is a better fit for families who speak Spanish at home. The classroom size went from 2 to 18 students with the change in location. Now there is 1 less PK classroom in the district. We still have capacity for 224 PK students and we haven't been full in PK in more than five years.
- This upcoming fall, as result of new DESE guidelines we will assign Kindergarten students in SEI-1 to a wider variety of elementary schools in order to integrate them with general education students.

Previous Questions from the School Committee

- Average stay of an SPS student here for medical treatment primarily from the UAE and Kuwait is 4.43 months
- 46% of Brown School students live in the Brown proximity
- Among all K-5 students 47 students have Brown proximity and don't attend the Brown School
- Among the current 101 K-5 Brown students with Brown proximity, 73 will have West proximity for middle school, 10 will have Kennedy proximity for middle school and 18 will have Winter Hill proximity for middle school
