I. CALL TO ORDER

The meeting was called to order at 7:01 with a moment of silence, followed by a salute to the flag of the United States of America. Chair Green asked Superintendent Skipper to call the roll, results of which were as follows: PRESENT – 7 – Dr. Phillips, Ms. Krepchin, Chair Green, Ms. Barish, Ms. Pitone, Dr. Ackman and Ms. Dion. ABSENT – 2 - Mayor Ballantyne, and President McLaughlin.

Chair Green announced that hybrid meetings would be discussed at the next meeting. He also announced that Superintendent Skipper and Dr. Ackman would be off camera for this meeting.

IV. REPORT OF SUPERINTENDENT

A. District Report

School Readiness

Superintendent Skipper began by welcoming everyone back and delivered her District Report for this evening: We are excited and ready to kick off the 2022-23 school year. Every year at this time, there is an enormous amount of work and coordination to get ready for the start of the school year. It is truly a community effort with many city departments, community agencies, and volunteers involved. I want to give a special thanks to our friends and partners at DPW for their unfailing support throughout the summer and in preparation for the school year.

Other partners helping with student readiness

In addition to our city partners, we are also fortunate to have organizations such as Cradles to Crayons and Somerville Kiwanis give generously of their time and resources to ensure that our students have the resources they need to start off the school year strong. Cradles to Crayons once again donated 2,500 backpacks with school supplies to support students throughout our district who may need a little extra help at the start of the school year. The Kiwanis Club of Somerville donated 109 PUMA brand backpacks filled with school supplies that will be used to support middle and high school students. We are so grateful to have businesses, community members, and organizations so invested in the success of our students. Thank you!

She also thanked the team that was present in the meeting and cabinet team for the tremendous work that they are doing to get school ready for the first day of school.

Superintendent Skipper then introduced Acting Superintendent, Dr. Curley to give a Fall COVID-19 Protocols update.

Fall COVID-19 Protocols

Dr. Curley then spoke to COVID protocols, which were previously shared via email.

A quick reminder that we are shifting our **COVID protocols** as outlined in an update to families and staff last week. Thankfully, we are in a very different place at the start of this school year than we were last year, therefore we are making adjustments accordingly.

- We are moving to symptomatic testing. Anyone who becomes symptomatic at school should visit the school nurse for a rapid COVID antigen test.
- We will be sending test kits home before school vacations and as needed in consultation with local public health officials. (Free testing kits are also widely available at pharmacies and various other locations in Somerville, including the libraries and City Hall.)
- Many of the mitigation strategies we put in place over the past two years will remain, that those include:
 - o Increased school and classroom ventilation
 - o Masks will be available to all students and staff who want them
 - o The option to require masks if needed in the case of an outbreak or concerning changes in the virus strain
 - Weekly reporting of positive cases on the SPS COVID-19 dashboard
- We ask families to help keep our cases low by doing the following:
- Every family should fill out the consent form for symptomatic testing for each of their students even if they filled out a similar form last year – so that we are able to test their child if they become symptomatic.. A link to the form was provided in the notice that went out. Even if families completed that form last year (COVID-19 Testing Consent Form)
 - \circ Please keep children home when they are ill. If they are showing symptoms of COVID, please test them at home with a rapid antigen test.
 - Report positive cases to the school nurse and by using the COVID-19 Reporting Form. Again, that link was included in the notice that went out last week and is available on our COVID-19 information webpage.
 - Per CDC/MDPH/SPS guidelines, positive cases must stay home for a minimum of 5 days, be fever free for 24 hours and have improving symptoms before returning to school. They must also wear a mast through day 10.
 - o If someone has had close contact with someone with COVID, we also ask that they wear a mast to school for 10 days after exposure.
- Vaccination is the best protection against severe disease and helps to slow the spread of new variants. We encourage everyone to get vaccinated against COVID, and will be offering vaccine clinics later this fall. To find a vaccine site now, visit vaxfinder.mass.gov.
- Dr. Curley introduced Interim Assistant Superintendent Dr. Boston Davis to talk about the Adventure Summer Program Highlights.
- Dr. Boston Davis read the summer school portion of the report.

More than 220 students participated in the Community Schools Adventure Summer program, along with 18 middle grades students who were part of the Leaders in Training (LIT) program. In addition, 17 high school students worked in the program. Students participated in a variety of project-based learning, which included a daily STEM block offered by DEILAB, and field experiences through trips to Museum of Science, Connor's Farm, and other locations. Students in the LIT program learned how to start up and manage

- a "Camp Store"; they learned about capital, revenue and expenses, supply and demand, and general accounting. They earned a profit of more than \$600 which they used to go on a field trip that the group voted on and donated a portion of the funds to purchase items that fellow students needed over the summer. Thanks to the United Way for providing \$30,000 in funding through their Summer STEP UP program for an additional 10 students entering grades pre-K to 2 to attend the program tuition free, and to support professional development for program staff.
- Dr. Curley than continue and gave an update on Community Schools

We currently have 764 students enrolled in Community Schools after school programs for the 2022-23 school year. An additional 112 students are on wait lists. Waitlisted families were notified early last week regarding their waitlist status and were provided with alternative programs in the community as we continue to work to hire more staff. Students who have not yet been placed will remain on our waitlists and will be contacted if a spot becomes available. Hiring will continue into September and October until positions can be filled.

Community Schools hiring staff will be participating in two college fairs in September in an effort to recruit therapeutic specialists – typically students who are working toward a social work or mental health degree – to support our high needs population. They are also working with the Program Director of Community and Work Based Learning at SHS, who is referring high school students to help fill high school helper positions.

We will continue to work as urgently as we can to recruit and hire additional staff so that we can place more students while maintaining safe student-to-staff ratios as required by the Department of Early Education and Care

Chair Green asked Dr. Curley to pause for questions-

Ms. Dion asked if parents are being informed of where they are on the waiting list. Dr. Curley responded that the initial commutation does not include that information, but it's a great suggestion he could bring back to Community Schools. Superintendent skipper added that numbers on the waiting list could me misleading as some school site's waiting lists move faster than others. It also depends on staff hiring.

Dr. Phillips asked as a Community School parent herself, could we confirm that if a child gets accepted an email will be received, but if the child falls on the waiting list you don't received anything. We need to have clarification for parents. Dr. Curley said that with the new system everyone gets an email, sometimes those emails go to spam. However, he will follow up.

He then continue with his report on Upcoming Important Dates

Finally, a reminder of some upcoming dates to keep in mind:

Not DPW summer work, but an important update SHS

- Over the summer, both chillers began experiencing issues. One chiller is completely down and the other is working at 75% capacity. The City building team has determined that the issue with both chillers was caused by equipment failures, which the manufacturer has acknowledged. That vendor is now mobilizing repairs under warranty at their expense. The chillers are the mechanical equipment that create the chilled water. The chilled water then gets pumped to all parts of the building where terminal devices control it to cool each space in the school. As we embark on a new school year, SHS will still be experiencing cooling capacity issues. While the City waits for the service contractor response to implement the necessary repairs, the City will implement a building occupancy plan that limits cooling in certain areas of the building so that the spaces of the building with the majority of occupancy can be cooled better. Here is the plan of action deemed necessary:

Reduced cooling will affect the following spaces (maintain min 76-78 degrees F): • Auditorium

- Dance studio
- Weight room
- Lecture hall
- Large group instruction
- Dining commons
- Hallways

<u>Priority cooling will affect the following spaces (maintain a maximum of 75 degrees F):</u> • Wing-A classrooms and offices

- Wing-B classrooms, offices, shops, and labs
- Wing-C classrooms, offices, shops, and labs
- Wing-D classrooms and offices
- Gymnasium
- Locker rooms

According to Director of Infrastructure and Asset Management Rich Raiche, the weather will turn cool before the necessary repairs are complete and this is due to supply chain and skilled labor shortages.

Chair Green I assumed we express our extreme displeasure that 2 year old Chillers are broken. Superintendent Skipper when we were notify about the situation we asked for an immediate meeting with the City to understand where the issue were, this is disappointing for our students and staff. We were assured that the parts would be order hoping this issue gets resolved guickly.

Ms. Pitone appreciate the transparency

Requesting that there is a communication to Staff on what they are able to do in terms of opening windows. Also, wondered if this issue affects the ventilation and air quality at Somerville High School. Mr. Mazza communication has been out to the staff, in terms to windows we want all windows closed. If windows are, open it forces the chillers to work harder and we want to make sure we maintained those. In terms of the second question, I can follow up with an email to the SC once I find out the answer.

Dr. Curley communication with updates will be sent out tomorrow, will confirm but 99% sure that is does not affect filtration system. Is not like WHCIS when the AC was not working the challenge is the humidity in the building Air circulation shouldn't be a problem.

Ms. Pitone- follow up field house last year we had the humidity issues, were we able to resolve that or because of the chillers, will this add to the issue.

Superintendent Skipper we did monitor the air during the summer with humifiers by adjusting the shades. Mr. Mazza the Gym is one of the priority are for the cooler because we already know the amount of student that will be in there.

Ms. Pitone- is there way to quantify where we are with hiring.

Chair Green- Added of all the new positions added how many have been filled and how many cant be filled

Sup Skipper- Responded that about 54 position are new hires. She referred to the Intra district hires for folks that who have moved around within the district. In terms of what still vacant hot spots are usually Food Service and paraprofessional, with new positions added SPED is also going in with some vacancies. They have been doing job fairs. Focus areas for hiring are at the Capuano and Winter Hill for SPED Paraprofessionals.

Ms. Barish- Where are we with crossing guards can family and which intersections will be covered? Superintendent Skipper the City has notify us that we have enough crossing guards to cover the main routes. We could reach out to the City for a list.

Ms Dion Universal position is that in the near future or a long term. Sup Skipper- We looking to start at WSNS now if all goes well we can certainly build it across other schools.

Dr. Curley added we have been working closely with the city Traffic and Parking to increase caution around school buildings -speed bumps across the city, Winter Hill, Healey, Capuano.

File: EBC-R - EVACUATION POLICY

The Somerville School Department will enforce the following Evacuation Plan when it is determined by the Administrator of the building, the Police Department, Fire Department or any other agency in authority that an emergency condition exists in the building or the surrounding neighborhood. During the first week of school, the plan will be sent to parents with a cover letter from the Superintendent. All new registrants through the year should also be given a copy upon admission to the Somerville school system.

This Evacuation Plan shall be included in the Somerville Comprehensive Emergency Management Plan. If the plan needs to be enforced for any reason, the Superintendent's office must be notified immediately. The staff in turn will notify the Police Department, Fire Department and city switchboard operator, to enable them to inform parents if they call, where their children are. It is understood that parental permission is not required before evacuation when it has been deemed appropriate to evacuate. Individual emergency evacuation plans for the disabled will be designed on site as needed.

COVID-19 VACCINATION & TESTING FOR EXTRACURRICULARS POLICY

Somerville Public Schools' goal is for students and staff to return to a safe school environment that will mitigate the potential exposure to and transmission of SARS-CoV-2. Widespread vaccination, routine testing, contact tracing, isolation/quarantine combine to mitigate the spread of COVID-19.

Vaccination is the most effective prevention strategy available for allowing schools to resume full in-person instruction. COVID-19 vaccines are available to all people age 12 and older. All educators, staff, and vaccine-eligible students (12 years and older) participating in Somerville Public School non-academic extracurricular activities must provide proof of COVID-19 vaccination. Extracurriculars providing academic support are exempted from this policy.

Eligible extracurriculars are voluntary, fall outside of the regular school curriculum, and do not offer academic support. The district will publish information online differentiating between academic and non-academic extracurriculars.

Effective from the date of adoption, any vaccine-eligible students seeking to participate in eligible SPS extracurriculars who are not yet fully vaccinated, must become fully vaccinated prior to October 20, 2021 or will not be eligible for participation in such SPS extracurriculars until fully vaccinated. SPS will publicize vaccination deadlines for participation in all athletics.

You are considered fully vaccinated:

- Two weeks after you have received the second dose in a two-dose series (PfizerBioNTech or Moderna) or
- Two weeks after you have received a single-dose vaccine (Johnson and Johnson/Janssen)

Acceptable documentation for verifying the vaccination status includes at least one of the following:

- CDC vaccination card which includes name of person vaccinated, type of vaccine provided, and date(s) administered, or a clear photo of the vaccination card.
- Documentation of vaccination from a health care provider with the information listed above.
- · State immunization information system record with the information listed above.
- Other school immunization record system that provides the information above.

Exemptions to the COVID-19 vaccine requirement will only be granted for documented medical or religious reasons. To receive the medical exemption, the individual must provide a written statement from a physician stating that a vaccine is medically contraindicated for the individual.

All students and staff participating in SPS extracurriculars are required to participate in the district's routine COVID-19 testing protocol. As long as the district is offering routine COVID-19 testing, this requirement applies to all district extracurricular activities. This will ensure that

the district can identify and swiftly isolate asymptomatic, pre-symptomatic, and symptomatic students and staff who are COVID-19 positive.

COVID-19 STAFF VACCINE REQUIREMENT POLICY

Vaccination against COVID-19 is the most effective means of preventing infection with the COVID-19 virus, and subsequent transmission and outbreaks. All educators, staff, and any other individuals providing services in the Somerville Public School buildings must provide proof of COVID-19 vaccination to the Human Resources department. Any staff who are not yet fully vaccinated, must get fully vaccinated prior to October 20, 2021. Any district staff who do not provide proof of vaccination must submit to routine COVID-19 testing provided by the district and always wear a KN95 (or equivalent high-grade surgical) mask inside school buildings, except when eating or drinking. Failure to comply with these health and safety protocols may be subject to progressive discipline.

You are considered fully vaccinated:

- Two weeks after you have received the second dose in a two-dose series (PfizerBioNTech or Moderna) or
- Two weeks after you have received a single-dose vaccine (Johnson and Johnson/Janssen)

Acceptable documentation for verifying the vaccination status includes at least one of the following:

- CDC vaccination card which includes name of person vaccinated, type of vaccine provided, and date(s) administered, or a clear photo of the vaccination card.
- Documentation of vaccination from a health care provider with the information listed above.
- State immunization information system record with the information listed above.
- · Other school immunization record system that provides the information above.

Exemptions to the COVID-19 vaccine requirement will only be granted for documented medical reasons. To receive the medical exemption, the individual must provide a written statement from a physician stating that a vaccine is medically contraindicated for the individual. Those with medical exemptions to vaccination must still participate in routine district COVID-19 testing.
